Guidelines for Smoke on the Square BBQ Competition

- Contest is limited to charcoal and wood only, no gas grills
- Teams will provide their own grills, charcoal or wood, seasonings, sauces, utensils, serving dishes, trash and used charcoal removal.
- Teams must provide their own wash basins for sanitizing with 1 lid of bleach to 1 gallon of water.
- · Any size grill, smoker, or cooker is welcome
- On-site set up begins at 12:00p.m. May 13, 2022
- Meat for judging to be provided by Contestant
- Judging in All Categories beginning at 2:30 p.m.
 - Categories: Meat (Chicken, Pork Ribs, Pulled Pork and Brisket), Dessert and BBQ Sauce
 - Meats will be judged on taste/flavor and texture/tenderness.
 - o Top Ten Contestants in meat categories will receive awards
 - Top Three Contestants will receive trophies and cash prizes
 - o Grand Champion and Reserve Grand Champion trophies will also be awarded
- Registration Fees
 - \$60 for Meat Categories and \$5 for BBQ Sauce and Dessert
 - No refunds of registration
